3. The bidder shall quote the bid amount in Rupees basis and not in fraction of paisa.
4. The bidder should be registered under CGST Act, 2017 and on M/s. MSTC Ltd.
5. The person who are interested to participant in auction should deposit Earnest Money of Rs. 50,000/- (Rupees Fifty Thousand only) to M/s. MSTC Limited, Vadodara

9. This Commissionerate reserves the absolute right to accept or reject any bid or to extend the bidding time or postpone the E-auction etc. without assigning any reason thereto.

10. The successful bidder will have to make the payment for the goods by **14.02.2024**. Thereafter, this office will take 05 working days for verification of payment/processing of file etc. before handing over the goods to the successful bidder.

11. The successful bidder shall make the payment of the applicable **IGST/CGST/SGST (@ 28% on bid amount)** and **CESS (@ 32% on M.R.P. for PAN MASALA & @ 56% on M.R.P for Chewing Tobacco)** on RCM basis through online mode by debiting his E-Cash Ledger only and generation of DRC-03 in consultation with the Officer (s) as mentioned in clause-1 of the T&C. The goods once handed over to the successful bidder shall not be returnable, either partially or fully, under any condition no refund of taxes/value amount will be made thereto.

12. In case successful bidder fails to deposit the bid amount, the EMD will not be refunded/returned and the bid will be awarded to the next highest bidder.

13. The bid amount quoted by the bidders will be displayed in the office notice board and the bidder who has quoted highest price will be intimated to lift the goods which are put to auction on payment of bid amount.

14. The successful bidder should lift the goods within five (05) days from the date of communication on payment of bid amount through online.
