11. The successful bidder will have to make the payment for the Vehicles by **16.03.2024**. Thereafter, this office will take 05 working days for verification of payment/processing of file etc. before handing over the goods to the successful bidder.

12. The successful bidder shall make the payment of the applicable **IGST/CGST/SGST/UTGST ( @ 18% on bid amount)** on RCM basis through online mode by debiting his E-Cash Ledger only and generation of DRC-03 in consultation with the Officer (s) as mentioned in clause-1 of the T&C. The goods once handed over to the successful bidder shall not be returnable, either partially or fully, under any condition no refund of taxes/value amount will be made thereto.

13. In case successful bidder fails to deposit the bid amount, the EMD will not be refunded/returned and the bid will be awarded to the next highest bidder.

14. The bid amount quoted by the bidders will be displayed in the office notice board and the bidder who has quoted highest price will be intimated to lift the goods which are put to auction on payment of bid amount.

15. The successful bidder should lift the goods within five (05) days from the date of communication on payment of bid amount through online.
