Subject: - Setting up of an IT Grievance Redressal Mechanism to address the grievances of taxpayers due to technical glitches on GST Portal - Reg.

A copy of Circular No. 39/13/2018-GST dated 03.04.2018 issued vide F. No. 267/7/2018-CX.8 by Government of India, Ministry of Finance, Department of Revenue, Central Board of Indirect Taxes and Customs regarding Setting up of an IT Grievance Redressal Mechanism to address the grievances of taxpayers due to technical glitches on GST Portal is enclosed herewith for information, guidance and necessary action.
